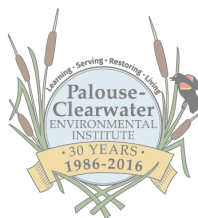

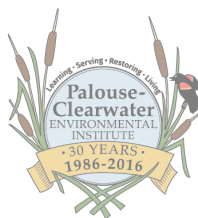

# Palouse-Clearwater Environmental Institute

## Liability Release and Photo Release

- **Notification of Risks.** Any participant in Palouse-Clearwater Environmental Institute (“PCEI”) activities or user of the Palouse-Clearwater Environmental Institute Nature Center (“Nature Center”) recognizes that there are risks including, but not limited to, variations in terrain and surface conditions and falls.
- **Supervision of Minor Children.** Parents or guardians or any other authorized persons shall be responsible for supervision of minor children at all times while participating in PCEI activities and/or using the Nature Center.
- **Assumption of Risk.** Any participant in PCEI activities or user of the Nature Center freely and expressly assumes all risks of personal and/or property damage which may be associated with and/or result from involvement in the activity or use and agrees to hold harmless, release, defend and indemnify PCEI of and from any liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage or injury, including death, that may be sustained by a participant or user while engaged in any PCEI activity or use of the Nature Center.
- **Release from Liability and Covenant Not to Sue.** In consideration for being permitted to participate in PCEI activities and/or uses of the Nature Center, the participant or user agrees to forever discharge and release from any legal liability and to not sue PCEI for any injuries or property damage caused by or resulting from the activities or uses.
- **Indemnification.** PCEI shall be indemnified by a participant in PCEI activities or user of the Nature Center for any injury and/or damage to any other participant in PCEI activities or user of the Nature Center or to other persons caused by such participant or user as a result of participation in any PCEI activity or use of the Nature Center.
- **Medical Authorization.** Any person who participates in PCEI activities or uses the Nature Center authorizes PCEI’s authorized personnel to call medical care for the person or to transport the person to a medical facility or hospital if, in the opinion of such personnel, medical attention is necessary. Any participant in activities or user of the Nature Center agrees that, upon such transport to any medical facility or hospital, PCEI shall not have any further responsibility. Further, any participant in activities or user of the Nature Center agrees to pay all cost associated with such medical care and related transportation and indemnify and hold PCEI harmless of and from any costs incurred therein.
- **Photo Release.** Photos of any person who participates in PCEI activities or uses the Nature Center may be used to promote PCEI and/or advertise PCEI events in the future.

## **Confidentiality Clause**

The volunteer/intern agrees that the volunteer/intern will not disclose to others or use, whether directly or indirectly, any confidential information for the volunteer/intern’s own benefit or for any purpose.
