Therefore, we strive to provide interns with technical experience, training and mentorship that adds value to their professional portfolio. Interns commit to a minimum of 3 hours per week for a period of at least 2 months. Typically, interns work outdoors doing hands-on work in environmental stewardship, restoration, and education/outreach programs. They may also have the opportunity to train and lead volunteers.

Responsibilities

Visit restoration sites in the Palouse region with PCEI AmeriCorps Restoration Technicians at least once each week, for approximately 3-4 hours, to perform restoration activities.

- Install native plants
- Install plant protectors and flagging materials, as needed.
